## CHRIS BRUNER IS NEW BOARD CHAIRMAN OF THE MANN

Klein served in that capacity for eight years, during which time he led the organization through two successful capital campaigns, raising nearly \$30 million, and most recently, guided the Mann through an 18-month strategic planning process. He has been a member of the Mann

board for 13 years and will continue on in that role. "Justin introduced me to the Mann, and it's been a great experience," said Bruner. "Like him, I have a lot vested in this organization and a keen interest in its long-term success."
